(NYSE:MOH) today announced that the widely respected National Committee for Quality Assurance (NCQA) has included Molina Healthcare's health plans in California, Florida, Michigan, New Mexico, Ohio, Texas, Utah, Washington and Wisconsin in NCQA's Medicaid Health Insurance Plan Rankings for 2013-2014.

All of Molina Healthcare's eligible health plans are ranked by NCQA, a private non-profit organization dedicated to improving health care quality and is widely accepted as an industry standard for identifying what are among the best health plans in the United States.

"For nine consecutive years our health plans have been nationally ranked for quality by NCQA," said J. Mario Molina, M.D., president and chief executive officer of Molina Healthcare. "We are extremely proud of this achievement especially since providing our members with access to high quality care has been our priority for the past 33 years."

Molina Healthcare of Utah is the only Medicaid plan in the state of Utah that is NCQA ranked and Molina Healthcare's Medicaid plans in New Mexico and Washington are the highest ranked in their respective states. In the overall national ranking of Medicaid health plans, Molina Healthcare of Michigan moved up 12 spots to No. 22; Molina Healthcare of Texas moved up 13 spots to No. 47; Molina Healthcare of Utah ranks No. 48; Molina Healthcare of New Mexico ranks No. 66; Molina Healthcare of Washington ranks No. 69; Molina Healthcare of Ohio ranks No. 71; Molina Healthcare of California Partner Plan ranks No. 96, Molina Healthcare of Florida ranks No. 97 and Molina Healthcare of Wisconsin ranks No. 122.
