**Explanation of Responses:**

- Annual grant of restricted shares under the Molina Healthcare, Inc. 2002 Equity Incentive Plan. The shares vest in one-quarter increments on each of 3/1/2010, 3/1/2011, 3/1/2012, and 3/1/2013.
- In addition to the shares vesting as noted above, increments of 1,387 shares vest on each of 3/1/10 and 3/1/11; and increments of 3,400 shares vest on each of 3/1/2010, 3/1/2011, and 3/1/2012. The remainder of the shares are vested.
- Represents the closing sale price of our common stock on Friday, 2/27/2009. In connection with the vesting of 4,788 shares of restricted stock on 3/1/2009, the reporting person surrendered 1,820 shares in payment of the taxes associated with the vested shares.
- The options are vested and exercisable.
- 5,500 of the options are vested. The remainder vest in increments of 2,750 options on each of 3/1/10 and 3/1/11.
