Since the grant date of January 1, 2024 was a non-trading day, the number of shares was calculated based on the closing price of the Issuer's common stock on December 29, 2023, of \$361.31. Thus, the grant this quarter for services as a Director is for 152 shares of the Issuer's common stock.
