The closing price of the Issuer's common stock on the last day of the immediately preceding quarter, December 31, 2014, was \$53.53. Thus, the grant this quarter for services as a director is for 1,168 shares of the Issuer's common stock.

- The 1,500 shares are held by the self-directed IRA of the Reporting Person's spouse.
